NONDISCRIMINATION CLAUSE

In the performance of all contracts, the contractor will be bound by the following nondiscrimination in employment clauses.

(1) The Contractor will not discriminate against any employee or applicant for employment because of race, creed, color, or national origin or physical or mental handicap.
